4 Treasurer's Report

The Treasurer's reports were presented, as follows:

a) Treasurer's Report: July 2013 to Dec 2013.

Financial year 2012-2013

The audited financial report for the period 1st July 2012 to 30th June 2013 was presented. (Please refer to the Audit Report prepared by our auditors, Sothertons)

The membership of the society has decreased this year and currently sits at 345. While the Profit and Loss statement in contrast shows an increase in revenue from the membership capitation fees, this is due to membership fees from 2012 being paid this financial year by the State branches. On a positive note, there has been an increase in advertising funding for our journal - Periodontology.

The main reason for our overall Net loss for the financial year was due to losses incurred with the last conference. Our general expenses have also increased slightly in certain areas, namely in donations/scholarships, journal printing costs and secretarial services associated with journal management.

As reported in the Balance Sheet, the society remains in a strong financial position. We have significant cash assets while our liabilities are minimal.

Financial quarters Jul 2013-Dec 2013

Unfortunately, this short time period does not allow for any meaningful judgement. While the Profit and Loss statement shows a loss for the first two quarters of this financial year, it should be recognized that the main reason for this loss is due to the 'transferring' of seeding funds. Notwithstanding, the society remains in a strong financial position (see Balance Sheet).
